1. Introduction

Voyara (“we,” “us,” “our”) is committed to protecting your privacy and ensuring the security of your personal information. 2. Data We Collect

We may collect and process the following types of personal data:

2.1 Information You Provide to Us

- **Payment Details:** Processed securely via third-party payment providers; we do not store credit card information.

2.2 Information We Automatically Collect

- **Usage Data:** Pages visited, time spent on the website, interactions, and referral sources.
- **Cookies & Tracking Technologies:** We use cookies, pixels, and analytics tools (e.g., Google Analytics) to enhance user experience and gather insights into website traffic.

2.3 Information from Third Parties

- If you book a trip using affiliate links or external platforms, those third-party providers may share transaction details with us (excluding payment details).

3. How We Use Your Data

We use your personal data for the following purposes:

- **To Provide Our Services:** Processing itinerary requests, sending confirmations, and managing travel-related inquiries.
 - **To Process Payments:** Handling transactions for travel consultancy services.
 - **To Improve Our Services:** Analyzing user behavior to enhance website functionality and customer experience.
 - **To Send Marketing Communications:** With your consent, we may send newsletters, travel deals, and exclusive offers.
 - **To Comply with Legal Obligations:** Ensuring regulatory compliance, fraud prevention, and security monitoring.

4. Data Retention

We retain your personal data only for as long as necessary to fulfill the purposes outlined in this Privacy Policy. Retention periods are as follows:

- **Account & Transaction Data:** Retained for up to **6 years** for legal and tax purposes.
 - **Marketing & Subscription Data:** Retained until you unsubscribe.
 - **Customer Support Inquiries:** Retained for up to **2 years** to improve service.
 - **Cookie & Tracking Data:** Retention periods vary (see our Cookie Policy for details).

All third parties are contractually required to safeguard your data and comply with applicable laws.
